Dear Mr. Y.C. Tsai,

With regard to your letter No: 10300002750 dated May 30, 2014, here with we inform you that Indonesia has lifted the prohibition of importation duck feather/duck down from Taiwan. The decision is based on the verification visit of our delegation to Taiwan, results of the risk assessment on Taiwan duck feather with on 21 February 2014 and monitoring of status situation of avian influenza in Taiwan.

In relation to the above matter, we are pleased to inform you that the duck feather/duck down products and other processed poultry products may entered into Indonesian territory if accompanied by Health Certificate with the addition explanation of the follows:

1. Processing methods that have been conducted on processed poultry products;
2. The statement that the processed poultry products are free from Avian Influenza (AI);
3. Explanation as points 1 and 2 must be declared in the HC that accompanies the entering of processed poultry products. Additional declaration of Health Certificate as attached.

At the entry point, the processed poultry products will be conducted quarantine action in accordance regulations in force.

These requirements has been established through issuance of Regulation of Ministry Agriculture No: 69/Permentan/OT.140/5/2014 concerning of Revision Of The Regulation Of Agriculture Minister No. 44/Permentan/OT.140/4/2013 On The Prohibition Of Importation Of Poultry And / Or Poultry Products From The PRC Into The Territory Of The Republic Of Indonesia.
