Description of content: Fresh melon fruits produced from pest free production sites of the Mediterranean fruit fly (<i>Ceratitis capitata</i> (Wiedemann)) of Honduras are approved to be imported into Chinese Taipei upon complying with these quarantine requirements: Melons which have passed inspection for exporting to Chinese Taipei shall be accompanied by phytosanitary certificates issued by SENASA (National Plant Protection Organization of Honduras). The phytosanitary certificate must contain the following additional declaration: "The melons have been inspected and found free from the Mediterranean fruit fly, <i>Spodoptera frugiperda</i> , <i>Helicoverpa zea</i> , Melon necrotic spot virus, and the Squash mosaic virus."; also, the name or the registration code number of the packing house must be noted.
